## 3. Documentary Requirements

#### a. 1st Envelope

a.1 PhilGEPS Certificate of Registration and membership.

In case of uploaded document/s, which validity period had already expired, submit the updated document/s.

- a.2 Statement of all its <u>Ongoing Government and Private Contracts</u>, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid;
- a.3 Statement of Single Largest Completed Contract within two (2) years prior to the submission and opening of bids with supporting documents, which should be equivalent to at least 25% of the ABC.

If the bidder will participate in more than one (1) lot, the basis of the NFCC shall be the highest ABC between/among the lots the bidder intends to participate in.

- a.4 JVA, in case of Joint Venture Class "B" Documents (Each partner of the joint venture shall submit the legal eligibility documents. The submission of technical and financial eligibility documents by any of the joint venture partners constitutes compliance, except for SSS Clearance that must be complied by all JV partners);
- a.5 Omnibus Sworn Statement (form supplied)
- a.6 NFCC Computation or committed Line of Credit (If the bidder will participate in more than one (1) lot, the basis of the NFCC shall be the highest ABC between/among the lots the bidder intends to participate in)
- a.7 Bid Security (2% of the ABC for Cash or Manager's/Cashier's Check payable to SSS or Bank Draft of the ABC, 5% of the ABC for Surety Bond **or** Bid Securing Declaration form supplied).

If the bidder opt to submit Bid Securing Declaration, it is considered applicable for all the lots. If other form of Bid Security the bidder shall submit on a per lot basis.
