***Request for Expression of Interest
REI-SSS-Consulting 2019-005***

***ARCHITECTURAL AND ENGINEERING DESIGN SERVICES FOR THE
PROPOSED CONSTRUCTION OF SSS TUGUEGARAO AND ZAMBOANGA
BUILDINGS***

1. The *Social Security System (SSS)*, through the Corporate Operating Budget FY 2019, intends to apply the sum of **P 14,932,000.00**, being the Approved Budget for the Contract (ABC) to payments under the contract for **Architectural and Engineering Design Services for the Proposed Construction of SSS Tuguegarao and Zamboanga Buildings**.

Bids received in excess of the ABC and the ceiling amount per subproject/item indicated below shall be automatically rejected at the opening of the financial proposals:

A. Proposed 2-Storey SSS Tuguegarao Building	-----	P 3,647,000.00
B. Proposed 4-Storey SSS Zamboanga Building	-----	<u>P11,285,000.00</u>
ABC	=	P14,932,000.00

2. The *Social Security System* now calls for the submission of eligibility documents for **Architectural and Engineering Design Services for the Proposed Construction of SSS Tuguegarao and Zamboanga Buildings**.

Eligibility documents of interested consultants must be duly received by the BAC Secretariat **on or before 27 June 2019 (Thursday) not later than 2:00pm. at the Green Room, 12th Floor, SSS Main Building, East Avenue, Diliman, Quezon City**. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.

3. Interested bidders may obtain further information from the **SSS** and inspect the Bidding Documents at the address given below from Monday to Friday, 8:00a.m. to 5:00p.m.
4. **A complete set of Bidding Documents may be acquired by interested bidders starting 18 June 2019 up to the scheduled submission & opening of eligibility documents** from the address below and upon payment of the applicable fee for the Bidding Documents, in the amount of **P 11,500.00**.

The mode of payment shall be on a cash basis payable at the SSS Cash Department, Ground Floor, SSS Main Bldg., upon accomplishment of SSS Form R-6. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.

It may also be **downloaded free of charge** from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the SSS, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known

as the “Government Procurement Reform Act”, and its Revised Implementing Rules and Regulations (RIRR).

The **short list shall consist of five (5) prospective bidders** who will be entitled to submit bids. The criteria and rating system for short listing are:

CRITERIA	RATING
A. Applicable work experience of the consultant	50 pts.
B. Qualification of personnel who may be assigned to the job vis-à-vis extent and complexity of the undertaking	30 pts.
C. Current workload relative to capacity	20 pts.
TOTAL	100
PASSING SCORE	80 pts.

- Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation (QCBE)*.
- The contract shall be completed within one hundred thirty-five (135) calendar days broken down below, reckoning from the date of signing of Contract and issuance of Notice to Proceed (NTP) and excludes the period of evaluation/approval in between stages of work:

Phases of Work under Design Stage	Duration (Calendar Days)
Schematic Design Phase	60
Design Development Phase	45
Contract Development Phase	30
Total	135

Schedule of project implementation for the design stage will proceed simultaneously for the two sub-projects/items. The consultancy services likewise include support services or non-full-time construction supervision during the construction phase of the Proposed 2-Storey SSS Tuguegarao Building and Proposed 4-Storey SSS Zamboanga Building, as specified in Section III. Eligibility Data Sheet, Item 1.2, Page 11.

- References to the dates and times shall be based on Philippine Standard time. Should any of the above dates fall on a holiday, the deadline shall be extended to the same time on the immediately succeeding business day in Quezon City.
- The Social Security System reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance

with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.

11. The Social Security System assumes no obligation to compensate or indemnify parties for any expense or loss that they may incur as a result of their participation in the procurement process, nor does SSS guarantees that an award will be made as a result of this invitation. Furthermore, the SSS reserves the right to waive any defects or formality in the responses to the eligibility requirements and to this invitation and reserves the right to accept the proposal most advantageous to the agency.
