- c. Bidder is in security system integration for at least five (5) years in the Philippines and system integrator partner of the proposed brand for the last three (3) years.
- c.5 Submit photocopy of valid certification, resume and company ID of at least five (5) manufacturer-certified engineers of the proposed brand Certified engineers should be employed by the bidder for a period of one (1) year before the bid opening. SSS shall validate the veracity of the submitted documents and may conduct, at its option, a visit to bidder's HRD office.
- **4.** Awarding shall be made to the bidder with the <u>Lowest Calculated and Responsive Bid</u> (<u>LCRB</u>).
- 5. All documents that need notarization should be notarized by the Notary Public himself/herself who has the authority to do so for the current year. A copy of the Authority to Notarize from the Notary Public must be submitted.
- **6.** Bidder must sign on each and every page of the Bid Proposal (1st and 2nd envelope).
