	Will the SSS sort the garbage before	Yes.
1	hauling?	
2	If the garbage is not sorted, is the garbage collector allowed not to haul?	Yes.
	In the case that the collector cannot haul the garbage within two (2) days due to unsorted garbage, will it be penalized?	No.
3	What will happen if the collector exceeds the one trip per day requirement to haul the garbage?	The requirement is for the winning bidder to haul a minimum of 18 cubic meters per day regardless of the number of trips.
4	What is the required size of the truck?	We have no required size of the truck for as long as winning bidder can haul a minimum of 18 cubic meters per day.
5	On the sanitary landfill, is the permit issued (ECC) by LLDA acceptable?	Yes.
6	When is the effectivity date of the contract?	Upon receipt of the Notice to Proceed (NTP) and Contract.
7	On the SLCC, can the bidder submit one contract as long as it is equivalent to the 50% of the ABC?	The requirement is at least two (2) similar contracts, the aggregate amount of which is equivalent to 50% of the ABC and the highest contract must be equivalent to at least 25% of the ABC. However, submission of one similar
		contract equivalent to 50% of the ABC is acceptable. This modifies Section III. Bid Data
		Sheet, clause 5.4.
