- Submission and opening of 2 envelopes: Monday, 04 January 2021, 2:00 p.m. at the 2nd Floor Bidding Room, SSS Main Building, East Avenue, Diliman, Quezon City

- a.2 Statement of all its <u>Ongoing Government and Private Contracts</u>, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid;
- a.3 Statement of Single Largest Completed Contract (SLCC) similar to the project to be bid, with supporting documents, equivalent to at least 25% of the ABC, completed within two (2) years prior to the submission and opening of bids, adjusted by the bidder to current prices using PSA's consumer price index;

For this purpose, similar contracts shall refer to any contract for the supply of gasoline and diesel within a fleet card system.

- a.4 NFCC Computation or committed Line of Credit (form supplied)
- a.5 JVA, in case of Joint Venture Class "B" Documents (Each partner of the joint venture shall submit the legal eligibility documents. The submission of technical and financial eligibility documents by any of the joint venture partners constitute compliance, except for SSS Clearance that must be complied by all JV partners);

- 3. Awarding shall be made to the bidder with the <u>Lowest Calculated and Responsive Bid</u> (<u>LCRB</u>).
- 4. All documents that need notarization should be notarized by the Notary Public himself/herself who has the authority to do so for the current year. A copy of the Authority to Notarize from the Notary Public must be submitted.
- **5.** Bidder must sign on each and every page of the Bid Proposal (1st and 2nd envelope).
