- Submission and opening of 2 envelopes: Thursday, 05 May 2022, 2:00 p.m. at the 2<sup>nd</sup> Floor Bidding Room, SSS Main Building, East Avenue, Diliman, Quezon City

## **Revised Schedule:**

- Issuance of Bid Bulletin No. 1—reply to written queries: Monday, 02 May 2022
- Submission and opening of 2 envelopes: Thursday, 12 May 2022, 2:00p.m. at the 2nd Floor Bidding Room, SSS Main Building, East Avenue, Diliman, Quezon City

Only one company representative is allowed to attend the manual opening of bids. Other company representative may witness the opening of bids through Microsoft Teams. Kindly coordinate with the BAC Secretariat for the details.

- 3. Documentary Requirements
  - a. 1st Envelope
    - a.1 PhilGEPS Certificate of Registration and membership.
      - In case of uploaded document/s, which validity period had already expired, submit the updated document/s.
    - a.2 Statement of all its <u>Ongoing Government and Private Contracts</u>, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid;
      - For projects with Non-Disclosure Agreement, bidders are required to disclose the projects and its details using Form-05 of the Bidding Documents
    - a.3 Statement of Single Largest Completed Contract (SLCC) similar to the project to be bid, with supporting documents, equivalent to at least 50% of the ABC, completed within three (3) years prior to the submission and opening of bids, adjusted by the bidder to current prices using PSA's consumer price index;
      - For this purpose, similar contracts shall refer to Installation and implementation of Domain Name System (DNS) Servers.

    - a.6 Bid Security (2% of the ABC for Cash or Manager's/Cashier's Check payable to SSS or Bank Draft of the ABC, 5% of the ABC for Surety Bond or Bid Securing Declaration form supplied) and a copy of the Authority to Notarize from the Notary Public).

    - 2022 Mayor's Permit

  - c.4 Two (2) demonstration units of the proposed product
- 4. Secretary's Certificate/Special Power of Attorney must clearly specify the name and position of the authorized representative who will:
  - a. submit its bid; and
  - b. sign the contract (in case of award)
- 5. Awarding shall be made to the bidder with the <u>Lowest Calculated and Responsive</u> <u>Bid (LCRB).</u>
- 6. All documents that need notarization should be notarized by the Notary Public himself/herself who has the authority to do so for the current year. A copy of the Authority to Notarize from the Notary Public must be submitted.
- 7. Bidder must sign on each and every page of the Bid Proposal (1st and 2nd envelope). Failure to do so shall be a ground for the rejection of the bid.
