- Submission and opening of 2 envelopes: Tuesday, 19 May 2020, 2:00 p.m. at the 2<sup>nd</sup> Floor Bidding Room, SSS Main Building, East Avenue, Diliman, Quezon City
- Submitted bids must be covered with plastic. This must be submitted directly to the Bidding Room at the 2<sup>nd</sup> Floor. The bidders must not use the elevator (use only the stairs) on the submission and take a picture where they dropped of their submitted bids. The guard on duty will coordinate with the BAC Secretariat in-charge for the receipt of the documents.
- 2. No clarifications raised after the Pre-Bid Conference.
