In case of uploaded document/s, which validity period had already expired, submit the updated document/s.

The largest of these similar contracts must be equivalent to at least 25% of the ABC.

If the bidder will participate in more than one (1) lot, the basis of the Single Largest Completed Contract shall be the highest ABC between/among the lots the bidder intends to participate in.
