- 4. Nobody paid/secured the Bidding Documents at the time of the Pre-Bid Conference.
- 5. The Technical Working Group (TWG) presented the background, scope of work and technical specifications of the project.
- 6. The following issues/clarifications were raised during the Pre-Bid Conference:

6.1	Are we going to buy two Bidding Documents for two lots?	Yes.
	If the lowest bidder wins for the Lot 1, he will also win for the Lot 2 if his cost proposal for the 2 Lots are the same?	No. A bidder must participate in both lots but shall be awarded for one (1) Lot only. Evaluation and contract award will be undertaken on a per lot basis.
6.2	On the submission of Appraisal Report, will there be a consideration for the delays due to travel restrictions caused by the pandemic?	The TWG will consider it during the implementation period but cannot commit as of now.
6.3	Would you also require us to do a market value appraisal of the parking slots? The requirement is a market value and a	Yes. The requirement is to have a separate valuation for the parking slot and the unit.
	market rent for parking slots?	Yes.
6.4	Are we going to upload the soft copy of bids to SSS or do we need to submit the hard copy?	Hard copies should be submitted since SSS does not have the facility yet for electronic submission. Only one company representative can attend the manual opening of bids. Other company repre- sentative may witness the opening of bids through Microsoft Teams.
6.5	Can we prepare a separate compliance to our ongoing and completed contracts?	The form for statement of all ongoing government and private contracts is supplied in the Bidding Documents. The Statement of Single Largest Completed Contract (SLCC) should have its attachments as supporting documents.
6.6	What is the basis of the 50% SLCC?	The basis is the total ABC for per lot.
	On the 50% SLCC, the ₱2,685,795.00 ABC for Lot 1 is good for two companies?	No. $\clubsuit$ 2,685,795.00 is for Lot 1 only (for 1 <sup>st</sup> and 2 <sup>nd</sup> year) which is also the same ABC for Lot 2. The bidder must have a 50% SLCC of the $\clubsuit$ 2,685,795.00 ABC to qualify for Lot 1 and Lot 2 within the last five (5) years prior to the submission and opening of bids.
6.7	On the submission of bids, two sets of bids will be submitted if the bidder will join the two lots?	The documents applicable for all lots and per lot will be indicated in the Bid Bulle- tin. Legal documents are applicable for all the lots while the technical and finan- cial documents should be separated per

		lot.
6.8	How many sets of bid does the bidder has to prepare?	Each Bidder shall submit five (5) sets, one (1) original copy and four duplicate copies marked as COPY Nos. 1-4.

- 7. The BAC Secretariat announced the Composition of Envelopes No. 1 (Eligibility and Technical documents), No. 2 (Financial Proposal) and additional documents.
- 8. The BAC II informed the bidders that the bid proposals will be subjected to Bid Evaluation. The bidder with the Lowest Calculated Bid (LCB) per lot shall be required to submit the following additional documents within non-extendible period of five (5) calendar days from receipt of BAC notice:
  - a. 2019 Income Tax Return (ITR) filed through Electronic Filing and Payment System (EFPS) corresponding to the submitted Audited Financial Statement;
  - b. Quarterly VAT for the period January to June 2020;
  - c. SEC/DTI Registration;
  - d. 2020 Mayor's Permit;
  - e. Valid Tax Clearance;
  - f. 2019 Audited Financial Statements filed through EFPS.
- 9. The BAC II emphasized that Sworn Statements/Affidavits/ Certifications must be:
  - a. Signed by the Notary Public (attorney) himself/herself;
  - b. The Notary Public has an updated Authority to notarize, issued by the Regional Trial Court.
