### **BRIEF DESCRIPTION OF FUNCTION**

Directs the investment operation functions in government securities and corporate fixed income instruments including trading activities in the fixed income exchange, conduct research functions and prepare recommendations for approval on fixed income related instruments which the various SSS funds may invest in or divest from, to achieve established objectives and targets.

### **MAJOR ACHIEVEMENTS**

As FIID Head, VP Ocay currently manages an investment portfolio of PhP 286 Billion in government securities and corporate bonds, which earned a total of PhP 16 Billion investment income for year end 2020. As the concurrent Head of Member Loans Department up to July 2021, she spearheaded and implemented member centric services especially pandemic related programs including Calamity Loan Online, Electronic Disbursement of Loans thru DBP Pesonet, Real Time Processing of Loans (RTPL) and Short Term Loan Moratorium Programs/ Housing Loan Moratorium Programs under Bayanihan 1 and 2. VP Ocay also implemented the Salary Loan Restructuring Program (LRP) for the years 2016 up to 2019 resulting to 1.1 Million member-borrower availments for total LRP booking of PhP 18.7 Billion.

As concurrent head of Alternative Investments Division in 2018, VP Ocay successfully deployed PhP 3 Billion investment in mutual funds in June 2018 and lead the engagement of external fund managers to manage total funds of PhP 7 Billion, first time in the history of SSS as a strategy to broaden the agency's investment alternatives.
