SUBJECT MANDATORY ONLINE TRANSACTIONS AND CHECKLESS

DISBURSEMENTS

Pursuant to Social Security Commission Resolution No. 364-s.2020 dated 08 July 2020 approving this Circular on the Mandatory Online Transactions and Checkless Disbursements to provide our members/employers/pensioners/claimants with safer, faster, more convenient, and economical means of registration, loan application and filing of benefits and disbursements and to comply with the requirements of the Ease of Doing Business and Efficient Government Services Delivery Act of 2018 or Republic Act No. 11032, the following online transactions and checkless disbursements shall be mandatory starting on the following schedules:
