A. Queries/Clarifications during the Pre-bid Conference:

	Queries/Clarifications	TWG/BAC Secretariat
1.	Just a question regarding the licensing, it says enterprise and perpetual licenses, does that mean the expectation is for perpetual type of license, would you not accept subscription basis?	We require a perpetual license that is for life, not a subscription.
2.	Will you allow us to use the credentials and the personnel from our principal for the project if we win the quotation?	If you will use the credentials and personnel of your principal company, there is a requirement in RA 9184 or the Procurement Law that you have to enter a joint- venture agreement.
	So we can't use our principal's credentials and resources unless we have a joint-venture agreement?	Yes.
3.	Clarification for Non-Disclosure Agreement (NDA) accounts: Because our clients are hesitant and agitated when called by our procurement entities, is it possible that we will include them but instead of calling them, we will simply provide a copy of the contract and cover some sensitive information there, because the only validation that needs to be done is the existence of the account's on-going contracts? Can we get an advance notice on which clients SSS will be calling so we can notify them? In our case, we have at least 50 ongoing projects; so that we can notify them for validation ahead of time? I'm hoping we can work it out.	Following verification with the GPPB, the submissions of project with non-disclosure agreement is still a requirement for procurement under public bidding. The projects listed in your on-going/completed contract are required for the computation of NFCC. Bidders need to fill-out the form no. 5 in the Bidding Documents for the validation of the percentage of the outstanding value of the contract. GPPB RA 9184, requires the validation of all the documents stated in the submitted lists of on-going government and private contract. GPPB advises us, if we can also advise our bidders, to simply inform your clients that we will verify the project's existence, so that they will know that SSS will call them during the post-qualification evaluation period.

That was also our concern, but the law requires that all ongoing projects submitted or stated in your documents must be validated, which is why the Technical Working Group is having a hard-time validating those projects. We'll just keep working on it.

4. Request for an extension for the submission on May 12, 2022 for bidders with joint-venture with their principal?

The deadline for the submission and opening of bids is re-scheduled from 12 May 2022 to 26 May 2022.

5. If Phil-GEPS is not available on the day of submission, can we submit the Class A documents for the meantime and to follow the Phil-GEPS on post-qualification?

The GPPB has already passed a resolution lifting the suspension of Class A document submission and requiring the mandatory submission of Phil-GEPS registration at the time of submission, and for RA 9184, the Phil-GEPS certificate of registration must be valid at the time of submission.

C. Other Instructions

Bidders are reminded of the instructions indicated in Section VII. Technical Specifications, page 31 of the Bidding Documents, as follows:

"Bidders must state here either "Comply" or "Not Comply" against each of the individual parameters of each Specification stating the corresponding performance parameter of the equipment offered. Statements of "Comply" or "Not Comply" must be supported by evidence in a Bidders Bid and cross-referenced to that evidence. Evidence shall be in the form of manufacturer's un-amended sales literature, unconditional statements of specification and compliance issued by the manufacturer, samples, independent test data etc., as appropriate. A statement that is not supported by evidence or is subsequently found to be contradicted by the evidence presented will render the Bid under evaluation liable for rejection. A statement either in the Bidder's statement of compliance or the supporting evidence that is found to be false either during Bid evaluation, post-qualification or the execution of the Contract may be regarded as fraudulent and render the Bidder or supplier liable for prosecution subject to the applicable laws and issuances."

Hence, bidders should properly label the evidence/s and cross-referenced with the statement of compliance.
