3	How about if we will join the two lots?	If you will plan to participate in two lots, you can submit the SLCC based on the lot with the higher ABC.
4	With regards to the wage increase under Wage Order No. RBVI-26 provides the minumum daily wages for non-agricultural/industrial/commercial employing will now be P450 from P395 effective June 05, 2022 in Western Visayas? Is it going to be implemented during opening or the awarding of contract?	The new wage order in Western Visayas was not yet considered in the cost computation. Implementation shall be made only upon awarding of contract.
5	What will be our basis in the payment for administrative fee? Is it the 10% or the 20%?	Admin Order (per DOLE #150-16) should be not less than 20%.
6	Philhealth has an increase of 4%, is it included in your excel computation?	Yes.
