8	Will you provide us at least one floor plan for measurement purposes?	You can conduct site survey. We will provide sample floor plans, but it will be limited for some Branches/SOs.	
9	For confirmation, analytics for alarm was not mentioned in the presentation but was stated in the Bid Documents, is it included?	Yes, analytics for alarm is part of the requirements, please refer to page 32 and 33 of the Bid Documents.	
10	DOM IP camera, is in video analytics. Is facial recognition a requirement?	Yes

We are clarifying this because our understanding is that the camera will be just used inside the branch office of SSS and we think that having this feature is unnecessary. This feature is actually found in the technical specifications of the Network Video Recorder not in the Bullet IP Camera and we are thinking that it might just be a typographical error.	Yes, for the Bullet IP Camera, the technical specification requirement is blacklist and whitelist license plate only, the word "license plate recognition" is included in the '8 Channel Network Video Recorder (NVR), see p. 34 of the Bidding Documents.
