For projects with Non-Disclosure Agreement, bidders are required to disclose the projects and its details using Form-05 of the Bidding Documents.

a.3 Statement of Single Largest Completed Contract (SLCC) similar to the project to be bid, with supporting documents, equivalent to at least 50% of the ABC, completed within five (5) years prior to the submission and opening of bids, adjusted by the bidder to current prices using PSA's consumer price index;

For this purpose, similar contracts shall refer to Contracts for Property Management Services.

- 4. Secretary's Certificate/Special Power of Attorney must clearly specify the name and position of the authorized representative who will:
 - a. submit its bid; and
 - b. sign the contract (in case of award)
- 5. Awarding shall be made to the bidder with the <u>Lowest Calculated and Responsive</u> <u>Bid (LCRB).</u>
- All documents that need notarization should be notarized by the Notary Public himself/herself who has the authority to do so for the current year. A copy of the Notarial Commission and Specimen Signature from the Notary Public.
- 7. / Bidder must sign on each and every page of the Bid Proposal (1st and 2nd envelope). Failure to do so shall be a ground for the rejection of the bid.
