This addendum/Bid Bulletin No. 1 is issued to clarify, modify or amend items in the Bidding Documents (BD) as a result of the Pre-Bidding Conference on 27 September 2022. This shall form an integral part of the BD.

Under Section 22.5.3 of the RIRR of RA 9184, it shall be the responsibility of all those who have properly secured the BD to inquire and secure Supplemental/Bid Bulletins that may be issued by the BAC.

2. Documentary Requirements

a.3 Statement of all its Ongoing Government and Private Contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid;

a.4 Statement of Single Largest Completed Contract (SLCC) similar to the project to be bid, **with supporting documents**, equivalent to at least **50% of the ABC**, completed **within five (5) years** prior to the submission and opening of bids, adjusted by the bidder to current prices using PSA's consumer price index;

For this purpose, similar contracts shall refer to contracts which have the same major categories of work, which consists mainly of detailed engineering design and construction of building and similar structures.

- Certification from the relevant government office of their country stating that Filipinos are allowed to participate in government procurement activities for the same item or product.

- Certification from the DTI if the Bidder claims preference as a Domestic Bidder or Domestic Entity.

- 3. Awarding shall be made to the bidder with the Lowest Calculated and Responsive Bid (LCRB).
- 4. All documents that need notarization should be notarized by the Notary Public himself/herself who has the authority to do so for the current year. **A copy of the Notarial Commission and Specimen Signature from the Notary Public.**
- 5. Bidder must sign on each and every page of the Bid Proposal (1st and 2nd envelope). Failure to do so shall be a ground for the rejection of the bid.


